Campus Ministry

"First Night at Newman" launched the August welcome events with one hundred freshmen moving onto campus a day early and coming to church for an evening dinner. For a number of years now, UK housing has allowed the Newman Center to invite incoming freshmen to avoid traffic getting into their dorms, and enjoy the hospitality of student and resident parish members at First Night. Along with the freshman 100, thirty upper class students formed the "New Crew" and organized the event with staff. Resident parish members and Newman Foundation board members provided the food, including fourteen derby pies.

First Night kicked off our "Ten Events over Ten Days." Liturgies, daily meals, community service, prayer, social opportunities and a camping trip helped create a climate of hope and a community of welcome. The events included graduate students and transfer students. Funding from Newman Foundation provided T-shirts for the New Crew; daily welcome meals from cookouts and a pancake breakfast to a barbeque along the Cumberland River; Mass schedule prayer cards and Catholic daily devotional booklets.



Camping at Cumberland Falls State Park completed the "K Week" events. Student organizers prepared dinner for forty campers on the banks of the Cumberland River. After dinner and a hike around the falls students joined in with the state park's line dancing event. The adventure continued Saturday with a hike and a swim beneath a small waterfall deep in the Daniel Boone National Forest.

Sign up Sunday, the first Sunday after UK classes began, invites all parish members at each Mass to sign up to help with various aspects of parish life. Today, students are now Eucharistic Ministers, lectors, servers, hospitality ministers, choir members, religious education teachers, bible study participants, servers and cooks feeding the inner city needy, weekend builders of our "Catholic Build" Habitat for Humanity house, retreat coordinators, intramural sports team coaches and more. Over 30 students teach on Sunday mornings in the parish religious education ministry.

Students are busy now with their class demands and campus involvement. Two student retreats are being planned to help students be mindful and awake to their spiritual life in the midst of their schedules. Newman Foundation funding will help keep the retreats affordable for students. After over thirty years, the Sunday spaghetti dinners continue after every 5PM Mass for weekly fellowship and relaxation. Different groups of parishioners volunteer to prepare the meal each week. UK's fall semester signals a new beginning for the parish with the arrival of new student parish members with their energy and spirit blessing our campus parish.


Letter from the President -Katie Yunker


